Terms and conditions

Agreement

- **Your access to the Ecouncil.ae Website means you explicitly agree on the terms and conditions, so you shall read them carefully.**

Ecouncil.ae Website Account

- You are solely responsible for the confidentiality and privacy of your username, password and log-on details and for any use of your account in the Ecouncil.ae Website.
- You agree to immediately notify the Abu Dhabi Executive Office of any unauthorized activity regarding your Ecouncil.ae Website account or any other security breach.
- At its discretion, the Abu Dhabi Executive Office may, at any time, suspend or cancel your Ecouncil.ae Website account with or without notice.

Controls of Use

If the use of the Ecouncil.ae Website is violated by you or any other person who uses your account in contravention to the terms and conditions or any other agreement or policy of the Abu Dhabi Executive Office, or if the use, at the sole discretion of the Abu Dhabi Executive Office, is unacceptable, unlawful or inconsistent with, disrupting or undermining the performance of the Ecouncil.ae Website, and without compromising any other right or remedy that the Abu Dhabi Executive Office may have, the Abu Dhabi Executive Office may suspend, decline or restrict your access to the Ecouncil.ae Website and it may also take any further action deemed suitable by the Abu Dhabi Executive Office to protect itself, the users and confidentiality of information.

You agree on not using the Ecouncil.ae Website in any form that may:

1. Be Illegal or violating the privacy of others.
2. Violate or abuse the confidentiality, intellectual property or other rights related to the Abu Dhabi Executive Office or others.

- Take legal action against you.
